Ingredients:	100% natural Rosa Alba Flower Oil

3. HAZARDS IDENTIFICATION

Personal precautions:	Avoid inhalation and contact with skin and eyes. A self-contained breathing apparatus is recommended in case of a major spillage.

Method for cleaning-up:	Remove ignition sources. Provide adequate ventilation. Avoid excessive inhalation of vapors. Large spillages should be soaked up with sand or an inert power, and deposited according to local regulations.
