2. COMPOSITION, INFORMATION ON INGREDIENTS

Ingredients: 100% natural Boswellia Frereana (Frankincense) Oil

3. HAZARDS IDENTIFICATION

Eye Contact: May cause eye irritation.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Avoid inhalation and contact with skin and eyes. A self-contained breathing apparatus is recommended in case of a major spillage.
Environmental precautions: Keep away from drains, surface and underground waters and soil.
Method for cleaning-up: Remove ignition sources. Provide adequate ventilation. Avoid excessive inhalation of vapors. Large spillages should be soaked up with sand or an inert power, and disposed of according to local regulations.
