DECLARATION OF ALLERGENS

acc. to Commission Regulation (EU) 2023/1545 of 26 July 2023 amending Regulation (EC) No 1223/2009 of the European Parliament and of the Council as regards labelling of fragrance allergens in cosmetic products

According to the information available to us, this product may contain the following maximum percentages of naturally occurring substances identified among the 82 fragrance allergens listed in Commission Regulation (EU) 2023/1545 of 26 July 2023, which amends Annex III of Regulation (EC) No 1223/2009 concerning the labelling of fragrance allergens in cosmetic products.

These ingredients must be declared in the product's ingredient list when their concentrations exceed 0.001% in leave-on products or 0.01% in rinse-off formulations. The values are presented as percentages by weight within the overall composition. Entries marked with “–” denote concentrations below 1 ppm, typically under the detection threshold when using standard analytical methods developed by the International Fragrance Association (IFRA) — including those described by Chaintreau et al. (2003, J. Agric. Food Chem., in press) and the official EN16274:2021 method for quantifying an extended list of 57 suspected allergens via gas chromatography-mass spectrometry (GC-MS).
